Minutes
Meeting of September 30, 2009

1. The meeting was called to order at 1:19 P.M.

Members present: David P. Gervais, BS, CNMT, NCT, Chairman; Carla White, CHP, RRPT, Vice-Chair; and Donna Holbrook, R.T.; Raymond McCandless, Ad Hoc Public Member. Participated via phone: Stephen Koller, M.D. Absent: Thomas Harty.

2. The Chair called for approval of the Minutes of the July 29th meeting. On page 3 the second paragraph was stricken. The first sentence of the fourth paragraph was amended to read: Director Winters said he agreed with Kevin Leahy. Other grammatical errors were corrected. Chairman Gervais made a motion, seconded by Ms. Holbrook, to approve the Minutes of the September 30, 2009 meeting as amended. Motion passed unanimously.

 - a. At 2:00 PM the Board considered a Stipulation and Consent Order in the matter of **Faye R. McCormick**, Docket Number 2009-137. The Respondent was not present. Larry S. Gregg Meyer was present for the State. Ms. White made a motion, seconded by Mr. McCandless, to find the Respondent in default. Dr. Koller made a motion, seconded by Mr. McCandless, to indefinitely suspend Ms. Davis' licenses as a Radiologic Technologist and a Radiation Therapist. Motion passed. Chairman Gervais, Investigating Member along with Ms. Holbrook did not participate in the vote.
