All, you have each made a request for the Governor's calendar. As documented in the emails produced on April 29, 2012, we have previously produced the Governor's daily outlook calendar, but at a cost. The cost of producing the Governor's daily calendar comes from the need to redact certain confidential information such as the names of candidates for judicial and other appointments, personal contact information, etc. We write to clarify the types of calendar information that we can produce at no cost to you, and otherwise to clarify the expected costs of producing additional days of the Governor's daily calendar.

We can produce every day of the Governor's public appearance calendar – this amounts to approximately 400 pages. If you would like the public appearance calendar, let us know.

We have previously produced approximately 500 pages of the Governor's daily outlook calendar at a cost. If you would like that previous production (which requires no additional costs), let us know.

Expected costs of producing additional days of the Governor's daily outlook calendar:

Previous production of 504 days = cost of \$154

Request for 1442 additional days (May 25, 2012 to today) = approximately \$450. In addition, please be aware that in light of current litigation, we need to review portions of the Governor's daily outlook calendar with the Attorney General's Office as portions of the outlook calendar contain terms contained in their litigation hold notice.
