

1 TO THE HONORABLE SENATE:

2 The Committee on Agriculture to which was referred House Bill No.
3 entitled “An act relating to water quality on small farms” respectfully reports
4 that it has considered the same and recommends that the Senate propose to the
5 House that the bill be amended by striking out all after the enacting clause and
6 inserting in lieu thereof the following:

7 Sec. 1. 6 V.S.A. § 4810a is amended to read:

8 § 4810a. REQUIRED AGRICULTURAL PRACTICES; REVISION

9 (a) On or before ~~July 1, 2016~~ September 15, 2016, the Secretary of
10 Agriculture, Food and Markets shall ~~amend by file under~~ file under 3 V.S.A. § 841 a
11 final proposal of a rule amending the required agricultural practices in order to
12 improve water quality in the State, assure practices on all farms eliminate
13 adverse impacts to water quality, and implement the small farm certification
14 program required by section 4871 of this title. At a minimum, the amendments
15 to the required agricultural practices shall:

16 (1) Specify those farms that:

17 (A) are required to comply with the small farm certification
18 requirements under section 4871 of this title due to the potential impact of the
19 farm or type of farm on water quality as a result of livestock managed on the
20 farm, agricultural inputs used by the farm, or tillage practices on the farm; and

1 (B) shall be subject to the required agricultural practices, but shall not
2 be required to comply with small farm certification requirements under section
3 4871 of this title.

4 (2)(A) ~~Prohibit~~ Except as authorized under subdivision (C) of this
5 subdivision, prohibit a farm from stacking or piling manure, storing fertilizer,
6 or storing other nutrients on the farm:

7 (i) in a manner and location that presents a threat of discharge to a
8 water of the State or presents a threat of contamination to groundwater; or

9 (ii) on lands in a floodway or otherwise subject to annual flooding.

10 (B) ~~In no case shall~~ Except as authorized under subdivision (C) of
11 this subdivision, manure stacking or piling sites, fertilizer storage, or other
12 nutrient storage shall not be located within 200 feet of a private well or within
13 200 feet of a water of the State, ~~provided that,~~

14 (C) ~~the~~ The Secretary may authorize:

15 (i) siting of manure stacking or piling sites, fertilizer storage, or
16 other nutrient storage within 200 feet, but not less than 100 feet, of a private
17 well or surface water if the Secretary determines that ~~a manure stacking or~~
18 ~~piling site, fertilizer storage, or other nutrient storage will not have an adverse~~
19 ~~impact on groundwater quality or a surface water quality~~ the site is the best
20 available site on the farm for the purposes of protecting groundwater quality or
21 surface water quality;

1 (ii) siting of a waste storage facility within 200 feet of a surface
2 water or private well if the site is the best available site on the farm for the
3 purposes of protecting groundwater quality or surface water quality and the
4 waste storage facility is designed by a licensed engineer to meet the
5 requirements of section 4815 of this title.

7 ~~(7) Prohibit the construction or siting of a farm structure for the storage~~
8 ~~of manure, fertilizer, or pesticide storage within a floodway area identified on a~~
9 ~~National Flood Insurance Program Map on file with a town clerk. [Repealed.]~~

10 (8) Regulate, in a manner consistent with the Agency of Natural
11 Resources' flood hazard area and river corridor rules, the construction or siting
12 of a farm structure or the storage of manure, fertilizer, or pesticides within a
13 river corridor designated by the Secretary of Natural Resources.

15 Sec. 2. 6 V.S.A. § 4871(b) is amended to read:

16 (b) Required small farm certification. Beginning on July 1, 2017, a person
17 who owns or operates a small farm, as designated by the Secretary consistent
18 with subdivision 4810a(a)(1) of this title, shall, on a form provided by the
19 Secretary, certify compliance with the required agricultural practices. The
20 Secretary of Agriculture, Food and Markets shall establish the requirements
21 and manner of certification of compliance with the required agricultural

1 practices, provided that the Secretary shall require an owner or operator of a
2 farm to submit an annual certification of compliance with the required
3 agricultural practices.

4 Sec. 3. EFFECTIVE DATE

5 This act shall take effect on passage.
