**Analysis of Bill**

The bill changes the rules of the Vermont Labor Relations Board (VLRB) to require it to redact from the Board's website *only* the name of any grievant whom the Board exonerates of misconduct for which he or she was disciplined. The name shall not be redacted from any other version of the Board's decision. This applies to all public employees who grieve to the VLRB.
2. **Is there a need for this bill?** *Please explain why or why not.*  
The bill sponsor was contacted by at least one former grievant who was concerned that non-redacted grievance decisions, particularly those where the grievant was exonerated, are easily available online without accurate context for people such as potential employers.
