# Sustaining Sub-national Climate Collaboration Beyond Paris

## Under 2 MOU–The Climate Group Partnership Proposal

### Purpose

---

With the goal of sustaining and expanding collaboration between sub-national governments beyond the Paris Climate Conference, and making the Under 2 MOU the benchmark and driver of ambitious climate action between now and 2050, The Climate Group proposes to formalize its partnership with California, Baden-Württemberg, and the Under 2 MOU by serving as the Secretariat for the MOU beginning in 2016.

### Role of the Secretariat

---

As Secretariat for the Under 2 MOU, The Climate Group would provide expanded administrative support in the following areas helping to maximize the impact of the MOU<sup>1</sup>:

**Reporting:** Support jurisdictions to report their climate actions to the Compact of states and regions (in lieu of an appendix). This would include capacity support for governments, tools and recommendations for integration with other reporting frameworks.

**Recruitment:** Support and streamline further targeted recruitment of additional state and regional governments of strategic relevance to sign the MOU.

**Communications and events:** Lead the media and communications strategy and support major events delivery<sup>2</sup> to ensure positioning of activities of the Under 2 MOU. Lead on internal communication with the signatories group including calls and meetings.

**Global Policy Learning:** Support government-to-government learning and collaboration on the eight topic areas identified in the MOU<sup>3</sup> and provide in-depth learning on specific climate actions and innovative policy responses.

**Partnerships:** Explore partnership opportunities in relevant areas such as reporting, recruitment and global learning to ensure alignment with existing efforts and expertise.

**Fundraising:** Lead efforts to secure the resources needed to implement the MOU, working with MOU signatories to coordinate efforts and secure statements of support.

### Organization

---

While the Secretariat would provide administrative support to implement the MOU, strategic decisions would be made jointly by the lead regions of California and Baden-Württemberg, along with representatives from The Climate Group, and possibly other MOU signatories.

<sup>2</sup> A first meeting could take place during the subnational summit at CEM7, hosted by California in May 2016.

<sup>3</sup> The eight topics include: energy; traffic and transport; natural resource protection and waste reduction; science and technology; communication and public participation; short-lived climate pollutants; inventory, monitoring, accounting, and transparency; and adaptation and resilience.
