Scott,
Sorry for the delay. This is the detail on the Michigan leases.

1. 24 month lease. This can be any length over 12 months.
2. 40,000 miles per year. This can be any amount as well.
3. Fixed Guaranteed maintenance included in lease payment
 - a. All preventive scheduled maintenance (oil changes, tire rotations, fluids...)
 - b. All repairs up to 80,000 miles
 - c. All failures up to 80,000 miles

This particular lease is a "Closed end lease", similar to a dealer type lease. We also offer an Equity Lease. This type of lease is similar to financing a vehicle, but to a residual value rather than \$0. This helps with cash flow and budgeting.

I know this is very vague, so please feel free to call me for more clarification if you want, but what I described above is exactly what we are doing for Gabriel.
