Dear Sen. Sears:

As a physician-scientist and professor at the medical school, I feel that it is important to express my concern that any *Cannabis* or *Cannabis*-infused products that come to market should be batched tested in a laboratory for potency and quality.

Over the past 3 years, I've worked with the VT medical marijuana non-profit dispensaries as a medical director to help set up chemical analysis of their products for potency measurements, and I was involved in S.14, introduced by you and Sen. White in the last session, to mandate labeling of potency of the active ingredients on all cannabis products. Now that there is discussion of possible legalization of Cannabis, I think it is especially important that we address the public risks of cannabis products coming to the retail market in Vermont, by mandating testing for potency and product safety in any such legislation.

Working with our partners at Bia Diagnostics, who are experts in food safety testing, we recently prepared the attached white paper with detailed recommendations on how testing should be conducted to ensure the public safety. We also enlisted help from a UVM business school faculty to model the cost to producers for such testing, which is included in this analysis. Finally, we also recommend that a portion of tax revenue from *Cannabis* sales are allocated to support the medical and technology research. I hope that you will review the summary of our recommendations and consider adding these to any future legislation in this domain.

I'm available to talk with you personally, or testify in committee, in support of mandatory testing of *Cannabis* products at your convenience. Please let me know if there is anything I can do to advance this public safety mission.

**Subject:** Re: Health Impact Assessment of Marijuana on VT

I have read the report and find it seriously flawed in many ways. I have prepared a critique of it which I have delivered to the Senate Judiciary Committee and will send to the Senate Health and Welfare Committee tomorrow. It is unscientific, it ignores research that does not suit its agenda, and strives to maintain the dominance of the law enforcement community in what I though had been agreed was a health problem.

It endeavors to undermine all the good work done in many areas; for example, the notion of adverse childhood events is tossed out the window and the use of cannabis is posited as the only explanation for poor academic performance, poor social interactions, and low income. It seeks to obscure the role that these adverse events plays in a youngster's development and place the use of cannabis front and center. It also undermines the impact of inequality as a driver of social ills.

The included graphic on health indicators is keen to list adverse outcomes (even if there is no demonstrated causation) and ignores several benefits that legalization could reap. They would include:

- \* assurance that the product was tested for additives and pesticides
- \* the product can be purchased outside of an illegal network, a network where other drugs are also on offer
- \* by implementing the three-pronged population-based approach, we can minimize the harmful effects of cannabis use, much as has happened with tobacco
- \* youth are expert at detecting adult hypocrisy; keeping it unlawful while 16% of the population uses, helps strengthen youthful disrespect for the law and for adult authority
- \* there is some early reports that cannabis can help opiate addicts maintain their abstention; at the methadone clinic where I worked in 2014 positive urine tests for cannabis were not a cause for program expulsion

You state that SAM and SAM-VT are not opposed to all reform yet as long as it is illegal to purchase cannabis, criminal sanction, not to mention professional sanction, will rule. As treatment and prevention professionals we need to recognize that over the past 40 years of the War, the large majority of funding for drug reduction has gone to enforcement efforts, victimizing poor communities and communities of color, and devastating regions subject to the force of US eradication efforts. We are left with the crumbs and continued criminalization of an activity that 16% of all Vermonters do has little to do with what drives me as a substance abuse professional.

[MONTPELIER, VT] - Today the Vermont Department of Health released a grim report on marijuana, *Health Impact Assessment: Marijuana Regulation in Vermont*, outlining health and safety issues related to the drug. The report's top-line findings are that marijuana negatively impacts most health and safety harms (p. 3) and that high school senior marijuana use would rise 6 points - or 10% - from 52% to 58% (p. 30). The report also predicted a staggering near-30% increase in emergency room admissions due to marijuana if the state legalized (p. 7), based on data from Colorado.

"Today's pot is not what Vermonters may have used in the 60s and 70s. The health impact is clear," remarked Kevin Sabet, President of SAM, Smart Approaches to Marijuana. "Governor Shumlin has been an outstanding leader on issues of substance abuse, with the glaring exception of marijuana. This report by his own department of health should be a wake-up call to any Vermont lawmaker mulling legalization," Sabet added. "This strategy will play into the hands of the increasingly well-financed marijuana lobby, which like Big Tobacco, seeks to put profits above public health."

In the report, several health and safety consequences are assessed - from psychosis to motor vehicle accidents to negative pregnancy effects - and almost all of them are found to be worsened by marijuana:

"Wall Street entrepreneurs are chomping at the bit to get into Vermont and sell things like marijuana-infused gummy bears and sodas," remarked Debby Haskins, SAM Vermont's Montpelier-based Executive Director. "The newly released health report specifically warns against edibles, but if the corporate special interests get their way and marijuana is legalized, all bets are off."

SAM-VT and SAM are not against all marijuana reforms. Both organizations urge Vermont lawmakers to adopt health, prevention, and treatment-related strategies toward marijuana. SAM does not support imprisonment for marijuana or hampering young people with unnecessary criminal records. Legalization and industrialization would, however, only make existing policies worse.
