7. Correspondence

- A. Dr. Jennifer Faul wrote the Board asking for an extension or waiver of the biennial continuing education requirements for her veterinary license. The Board requested that a response be sent to Dr. Faul that the Board does not have the authority to waive the continuing education requirements, however they do have the authority to grant her an extension of up to 90 days. She is allowed, by rule, to complete all of her continuing education credit online. Also, articles in Veterinary Learning Systems Compendium may be used for up to eight credit hours. She would need to provide proof of successful passage of the corresponding examinations. The Board feels that continuing education from personal attendance is the best, however, it cannot restrict her from getting the required continuing education credit online.
- B. Dr. Anne Bazil wiche-mailed the Board regarding outside prescriptions. Ms. Preston and Attorney Novins will research this further and will add it to the Board of Pharmacy's agenda and will report back to the Board at its next meeting.
