Erica Fanning emailed the Board asking if a masters level school psychologist who has an educators license in the areas of school psychology (not a psychology license) are able to diagnose students with things such as ODD, CD, ADHD, Bipolar, etc. The Board responded that the scope of practice for school psychologists is governed by the Department of Education statutes and rules, not those of this Board.
