**Analysis of Bill**

---

**1. Summary of bill and issue it addresses.** *The initial bill introduced proposed a number of measures to enhance privacy protections. 1. Required a search warrant for law enforcement to obtain records from a company providing electronic communication services, remote computing services or location information. 2. Established right of action for a person whose health care information was improperly disclosed. 3. Established regulations for law enforcement agencies to use unmanned aerial vehicles or drones. It is proposed a search warrant must be obtained or emergency circumstances must exist. 4. Restricted the time frame to 24 hours that captured data is kept from the automated license plate recognition (ALPR) systems.*

**The final bill (S.18) was amended and passed by the house and senate. All parts of the bill were deleted except for the effective date and sunset of the current. Law. The current law applying to our ALPR system (23VSA 1607 and 1608) states it will be repealed on July 1, 2015. The passing of this bill would make the effective date and sunset July 1, 2016. All other details of the current law remain in effect.**

- 2. Is there a need for this bill?** Yes. The ALPR system is used statewide by a number of different law enforcement agencies. The current law gives law enforcement guidance on how to law enforcement uses, stores and retrieves data from the ALPR system.
