### House Committee on Health Care

- Medicaid ACO – Mark Larson, Kara Suter, Susan Barrett (Director of Public Policy, Bi-State Primary Care Association), Jack Donnelly (CEO Community Health Centers of Burlington). [VTDigger Article 11/5/2013](#).
  - State Health Care Innovation Plan discussion.
  - ACO as part of payment and service delivery model.
  - ACO Shared Savings Program – performance-based contract between payer and provider organization that sets forth a value-based program for shared savings.
  - Year one SSP Experience: 18 of 32 health systems lowered Medicare costs, improved patient care, and \$33 million in net savings to Medicare trust fund.
  - Year two will allow participating ACO to take a broader reform role.
  - Year three will broaden cost of care.
  - Committee members ask, ‘what is the rush?’ to which the response is: voluntary program, way to engage providers in reform.
- Vermont Health Connect Update – Mark Larson, Robin Lunge, Kevin Goddard, Susan Gretowski, Christine Alibrandi (Delta Dental), navigators.
  - Many questions about numbers and whether this outcome was predicted. Even if numbers bump up, still doesn’t look good. Mark Larson responds that if you look at Mass Connector, sign up rates look like a hockey stick with a dramatic increase as deadline looms.
  - 50 percent improvement in page load times between weeks one and four.
  - Discussion of partnerships with businesses, hospitals, libraries, and VPIRG as well as VHC events around the state.
