**1853 - 150th Anniversaries - 2003
First International Railway in North America
Creation of Island Pond Village**

This year the Town of Brighton celebrated the 150th anniversary of two local historic events. In July 1853 the Grand Trunk Railway of Canada was born, linking Montreal, P.Q. with Portland, Maine through our area. It established the Village of Island Pond as its great halfway terminal.

John Alfred Poor of Portland was the key American promoter of this railway. He had purchased much of the land that is now Island Pond and was influential in making this decision.

From 1853 until recent years, the railroad was the principal employer of the Town and contributed to its prosperity. The Island Pond Historical Society commemorated these historic occasions at its annual meeting in August, 2003. It is appropriate for the Town of Brighton to recognize John Poor and these important milestones in local history.

Warning for Annual Town Meeting 2004

The legal voters for the Town of Brighton and the Brighton Water System are hereby warned and notified to meet in the Town Hall in said town on Monday, March 1, 2004, at 7:30 P.M. to transact the following business:

Articles 1 through 3 are to be voted by Australian ballot at the polls on Tuesday, March 2, 2004, from 9:00 AM to 7:00 PM in the town hall:

1. To elect the following Town and Water System officers: Moderator, First Constable, Town Agent, Town Grand Juror, Delinquent Tax Collector, one Lister, and one Auditor, all for one-year terms; one Selectperson, one Water Commissioner, one Lister, one Auditor, and one Cemetery Commissioner for the term of three years each; and one Library Trustee for the term of five years.
2. To elect the following School District officers: Moderator for a one-year term; one School Director for a two-year term; and one School Director for a three-year term.
3. Shall the voters authorize the Northeast Kingdom Waste Management District to appropriate and expend a budget of \$464,608.39?

The following articles are to be considered at the business-meeting portion of the Annual Town Meeting, to be conducted on Monday, March 1, 2004, at 7:30 P.M. in the town hall:

4. The Pledge of Allegiance to the Flag.
5. To hear the reports of the town officers for the past year and to take action thereon.
6. To hear the report of the Water Commissioners for the past year and to take action thereon.
7. To see if the voters shall fix the number of installments and the payment due dates for the collection of taxes as authorized in Title 32, V.S.A. Section 4872. Recommended payments to be due on August 17, September 17, and November 17.
8. To see if the voters shall authorize collection of 2003 taxes through the treasurer as provided for in Title 32, V.S.A. Sections 4792 and 4793.
9. To see if the voters shall authorize the Board of Selectmen to borrow money for the operating expenses of the Town of Brighton in anticipation of taxes—such borrowing not to exceed 90 percent of all anticipated revenues.
10. Will the voters authorize borrowing up to \$25,000 to be repaid over five years for design and permitting activity for sidewalk improvements?
11. Will the voters authorize borrowing up to \$20,000 over three years to re-point the south side of the railroad depot?
12. Will the voters authorize borrowing up to \$75,000 over five years to purchase a used grader?

13. Will the voters authorize spending up to \$10,000 as required match for a state grant to study septic issues around the lake?
14. Will the voters authorize spending up to \$8,000 for Holiday Season decorative lights for the downtown?
15. Will the voters appropriate the sum of \$500 to the cemetery commissioners for cleaning and repair of cemetery monuments?
16. Will the voters authorize the Selectmen to accept gifts, grants or other income and to make use of such income in their discretion?
17. Will the voters authorize the expenditure of \$201 for an appropriation to Rural Community Transit?
18. To see if the voters will raise money by property taxes to pay the general expenses of the town and if so, how much.
19. To check the feelings on a Commercial Wind Farm Facility in the Town of Brighton by a show of hands.
20. To transact any other non-binding business which may legally come before this meeting.

Selectmen's Report

This year's budget shows an eight percent increase over last year's approved budget. The increases, in many cases, are beyond the control of the Selectmen. Health insurance is up 20%, and the increase in the cost of health insurance amounts to over \$7,000. The cost of our general insurance (property, casualty and liability) is up over \$3,000. The County Tax is up \$6,500. An audit is needed at an estimated cost of \$6,500. The first payment on the new red town truck is due, adding almost \$23,000 to this year's budget.

Other proposed increases include those for necessary maintenance work on the municipal building, train depot, town garage and the road system. This includes adding a porch roof to the main entrance to the municipal building for ice protection, work on the eaves, canopy, windows and alarm system at the depot, and painting at the town garage (about \$10,000 for all). (Next year the municipal building will need significant work around the eaves and windows.) The Warning also includes a request for up to \$20,000 to re-point the south side of the depot. The rest of the building has been re-pointed.

A culvert inventory has been completed and we have identified culverts in need of replacement amounting to over \$7,000. Dale Avenue and North Streets are scheduled for re-surfacing, but we have put off re-surfacing Forest Street until next year. The Contracted services line item is currently set at \$15,600 to pay for street sweeping, road grading and mowing. However, there is an article on the Warning to see if voters will authorize purchase of a used grader for up to \$75,000 over five years. If that purchase is approved, the Contracted services line item will drop by \$8,000. There is an additional \$2,000 added to the equipment fuel line item in the event voters approve the grader purchase.

The decision to ask voters to buy a grader comes from a need to supply residents with better service for their tax dollar. Currently, we want the roads graded at about the same time other towns want their roads graded, so there is some difficulty obtaining the service when we need it. Because of the costs associated with contracting, we do not hire the grader as much as necessary to properly maintain our roads. If we did hire the grader a sufficient number of times, we would be paying enough to make it worthwhile to have our own grader. To keep the roads properly graded, we estimate it will cost about \$17,500 a year, instead of the \$8,000 we now spend. At that rate, we would be able to buy a good used grader in five years, and then be able to remove this cost from the budget for a substantial number of years (except for associated maintenance costs).

We continue to press for sidewalk improvements. We have completed a mostly grant-funded \$20,000 feasibility sidewalk study. We are ready to move to construction of the Main Street sidewalk from Cross Street to Mill Street. The sidewalk line item thus includes a \$4,000 increase for that work. For other sidewalks, the next step is design and permitting, and we are asking voters in the Warning to approve a loan up to \$25,000 over five years for that purpose.

The Island Pond Public Library will get a major renovation this year, expanding into unused space in the municipal building, and making other major improvements. This will be funded by a \$177,000 grant from the Vermont Community Develop-

ment Program and up to \$50,000 from the USDA, a legislative appropriation, and local sources. The Library Trustees are asking to level fund the Library services budget, and are asking that the Librarian's hours be increased and wage be raised to an appropriate level.

The line item for the Listers is increased because the Selectmen and the Listers feel it is time for the town to initiate a tax-mapping program. Under the new state grand list process the Listers enter the acreage and the value is automatically computed. For fairness, it is most important that the acreage of each parcel is accurate and that all parcels are accounted for. Getting tax parcel maps will enable this.

We have added \$4,000 to the Waste Management line item to pay for a bulky day at which residents may dispose of unwanted bulky items such as couches and mattresses, and to pay for signs and security cameras at the new recycling center, owing to the unacceptable amounts of illegal dumping occurring there. On the positive side, the recycling center will soon be accepting used oil and batteries and fluorescent light bulbs

Long-term debt is up by \$10,000 because the town did not receive some of the grant reimbursements in this fiscal year and had to borrow additional funds. Those reimbursements will show up this year in the revenue side of the budget under Refunds & Reimbursements.

Last year, with the support of the voters and some grant monies, a number of good projects were completed. A new 50-year warranty steel roof has been put on the municipal building (supported by a \$15,000 grant from Historic Preservation). The sidewalk feasibility study (supported by a \$16,000 grant from the Enhancement Program) has laid out the issues and given us direction for a more extensive sidewalk improvement program. A new \$11,000 culvert was put in on Five Mile Square (supported by a \$10,000 grant from the Agency of Transportation). A mile of Pleasant Street was re-surfaced (with the help of an \$85,000 grant from the Agency of Transportation). Newark Road was re-graveled (with the support of a \$12,000 grant from the Agency of Transportation). The first reappraisal in over 15 years was completed, resulting in a significantly increased and more equitable Grand List and lowering the tax rate dramatically. A new recycling shed was built (with the support of a \$3,100 grant from the Waste Management District).

The increased economic and construction activity in Island Pond has caught the attention of legislators, economic development professionals and potential business developers. The town is moving forward, and this budget reflects our best judgments about what is needed to keep the town on the track to prosperity.

Lastly, little happens without the support of good employees, and people of good will, and for both we are thankful. Towns, by law, need to have people fill statutorily created local offices. From time to time, there are openings on various boards, such as Planning and Zoning boards, Auditors, Listers, Library trustees, and other offices. The town very much needs people to serve their community by volunteering to perform the critical functions involved in running a municipality. 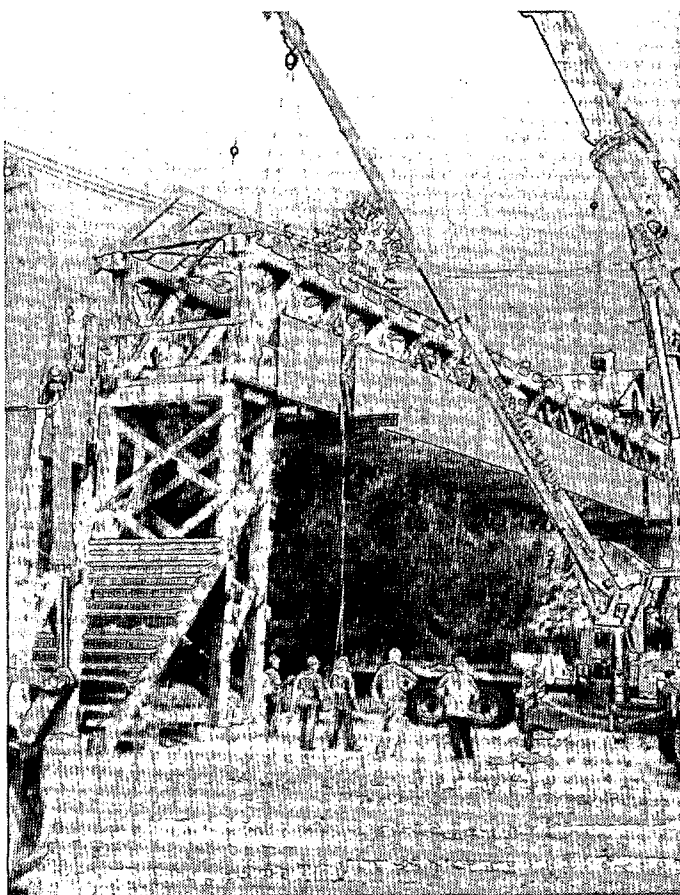

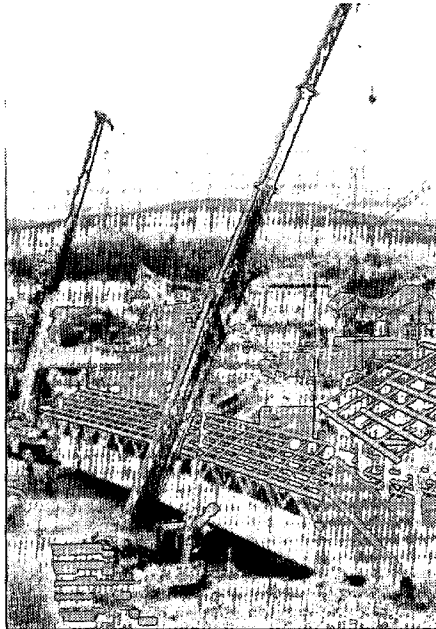

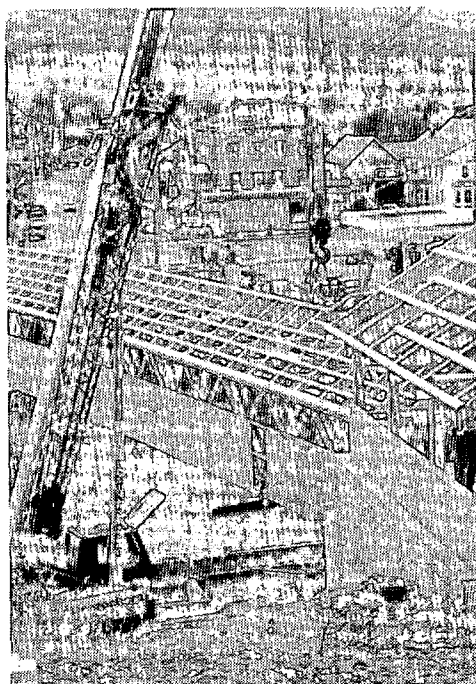

Librarian's Report

In 2003 the Board of Trustees for the Island Pond Public Library had a vision of what the library should and could be, and set in motion a dynamic plan to accomplish this goal. When I was asked to become Director of the Library on May 1st, I was glad to become part of this project and help to steer us on the course they had set.

That same month we received a Vermont Public Library Foundation - Freeman Foundation grant in the amount of \$17,190. This allowed us to acquire some essential equipment, books for adults, and most importantly to hire an assistant librarian so we can provide better services and longer hours (we are now open 28 hours a week, including Thursdays until 7:00 pm). Rebecca Murray filled that position and became a vital part of our team. With a team effort we were able to participate in the Summer Reading Program for children by hosting six events and inspiring our participants to accomplish their book reading goals.

As this was happening, the Board, including new member Krystyna Kurzej, and led by the efforts of Secretary Elizabeth Cope, began the fund-raising and assembling of a grant appeal to expand and renovate the library in order to have the space and facilities we so desperately need. Through private donations, book sales, bake sales, raffles and a coin drop, the citizens of Brighton and surrounding towns participated. We at the Library continued to work with what we had to make it a better place (though still small) to visit and to use.

Subsequently, our grant appeal was accepted for hearing by the Vermont Community Development Program. We went before them on Dec. 10th, and through all the efforts of the Board, myself, and representatives from the town and the school, we were informed by Dec. 20th that we were going to receive \$177,135. This, along with the other funds raised, will allow us to accomplish the plan that started the year.

We were recognized by the Department of Libraries for meeting a new Standards level heretofore not attained by the library, have added hundreds of new books, upgraded our computer facilities (including high-speed internet access), and started to coordinate programs with Brighton School and provide more hours for High School student access.

I look forward to continuing our work (and there will be plenty of it) in the coming year so that we can fulfill the vision that brought me here to begin with.

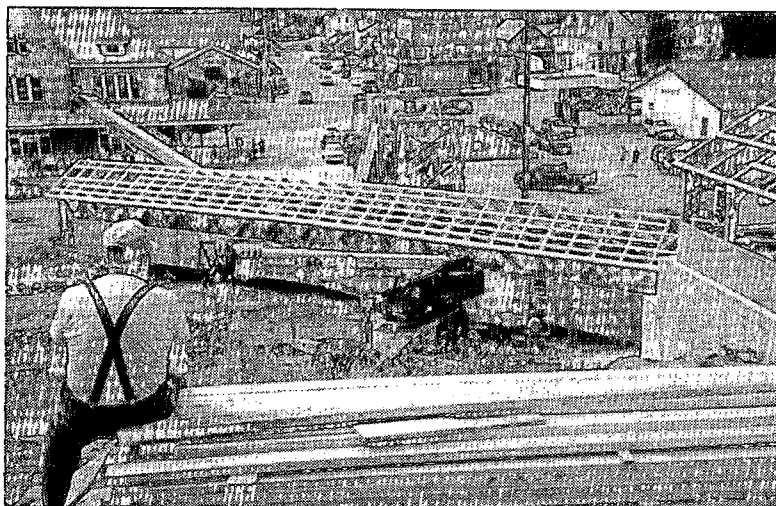

Brighton Fire Department Report

It's been a very busy year. Many of our members attended our regional school for a weekend of training in a wide range of activities. These included propane gas, vehicle extrication, air pak, and interior fire fighting. There was also a rookie course for our entry-level members. Instructors from the Rescue Training Institute came here for a 2-day vehicle extrication course that was very informative and exciting.

The Vermont State Fire Fighters Association held its annual convention in Newport. We participated in the parade. We also participated in the Pittsburg, NH convention parade.

Keith Weaver, Refuge Manager of the Sylvio O. Conte National Fish & Wildlife Refuge, provided the department with support and assistance. One benefit of this help was a FEMA Grant that provided our firefighters with clothing, hand tools and a portable pump. Keith also helped us obtain through donation, an enclosed snowmobile trailer to carry our equipment.

We also received a Homeland Security Grant to purchase a UHF radio for the truck and a thermal imaging camera. This can be used to detect "hot spots" in walls or elsewhere that may not be visible to the naked eye. It may also be used to search for missing persons including a person who may have been ejected from a vehicle.

We still meet the second and fourth Mondays of every month. Please feel free to stop in anytime with questions or to view the equipment.

Kingdom Corps

THE NORTHEAST KINGDOM CONSERVATION SERVICE CORPS

Thanks in part to the support from the residents of the Town of Brighton, the Kingdom Corps was able to provide educational and employment opportunities to 54 local youth while completing priority conservation and community service projects throughout the region.

Well over 100 young people applied to the Corps for 2003, nine of which were selected from Brighton to work on six conservation crews. This summer the Corps fielded its first ever backcountry crew made up of 16-18 year old youth who worked and lived in the backcountry for a week at a time. One of the positions on the backcountry crew was filled by a young person from Island Pond who had a very powerful experience, and in fact after the summer he went to school for urban forestry.

The leadership team is crucial to the success of the program and this summer two crew leaders and four JR leaders were young people from Island Pond. Most were past crewmembers and all proved successful at taking on a high level of responsibility and leadership. One of those leaders met our ideal criteria of having worked her way up from a 13-year old crewmember to the leadership role she served in during 2003.

In total \$20,640 in wages were paid directly to young people from Island Pond during the summer of 2003.

Crews worked on a variety of projects in the area including work on public lands, trails, riverbanks and in State Parks. 2003 was a successful summer and I am confident that the community of Island Pond benefited both from the work that was completed and even more so from the lessons that its youth gained through the Kingdom Corps experience.

Northeast Kingdom Waste Management District

2003 REPORT FOR THE TOWN OF BRIGHTON

The Northeast Kingdom Waste Management District provides many services for the town of Brighton. Most people know us as the recycling center on Church Street in Lyndonville, but we are much more than that. Materials such as used motor oil, fluorescent bulbs, hazardous waste, electronics, scrap metal, and lead-acid batteries are also accepted year round, and hazardous waste is collected during the summer.

Brighton constructed a new recycling center during 2003 with the help of the NEKWMD and a grant from the State of Vermont. The NEKWMD also did the paperwork to certify the new recycling center. The 2003 recycling rate for the Town of Brighton was 21.5%. Every ton of trash costs approximately \$100, while recycling costs the town \$44.75 per ton in hauling fees. Therefore, as residents recycle more the town can lower its overall waste management costs.

A household hazardous waste collection will be held in Brighton this next summer. The NEKWMD also runs a household hazardous waste collection through the summer months at the Lyndonville recycling center. This is open to residents and conditionally exempt generator businesses from all NEKWMD towns. Used motor oil, lead-acid batteries and fluorescent light bulbs will soon be collected at the Brighton recycling center. These materials are removed and properly handled by the waste district.

The money for the NEKWMD budget comes from the sale of recyclables (20%), State grants (3%), hauling fees (8%), miscellaneous fees and income (9%), and a surcharge on every ton of trash disposed of from NEKWMD towns (60%). This surcharge is dropping from \$21.50 to \$21.00 for 2004 – this is the fourth year in a row that the surcharge has dropped. Residents of the Town of Brighton paid 1.5% of the District budget in 2003, based on hauling fees and surcharge.

We are looking forward to a full slate of events during 2004. The hazardous waste depot will be open from June 1 to October 1 by appointment. A hazardous waste collection is planned in Brighton on Monday, August 2 from 10 am to 1 pm. Clothing drop and swaps are scheduled for April 9-10 and September 10-11 at the Fenton Chester arena in Lyndonville and spring and fall in Derby – these events have grown in popularity over the last two years, and we now regularly send 2/3 of the clothing collected back into the community for reuse!

Northeastern Vermont Development Association

True to our mission, Northeastern Vermont Development Association (NVDA) worked hard during the past year to meet the economic development and planning needs of the region's municipalities and businesses. 2003 was our 53rd year of dedicated service to the people of the Northeast Kingdom.

Many of our projects were regional in nature and therefore benefited every single community in this region. A good example of this is the unmet transportation needs survey, which gauged the gap between the availability of and the need for transportation services in the Northeast Kingdom.

We also continued to provide essential technical services to town and city officials. This work included conducting transportation studies (including a bridge and culvert inventory) and traffic counts (including counts in Brighton); preparing, reviewing and commenting on municipal planning documents; certifying Municipal Plans; interpreting and explaining planning law, as well as wind power and local zoning issues, to planning and zoning officials; and preparing GIS maps. NVDA also continued to offer reliable and knowledgeable grant writing and grant administration services to a number of towns. NVDA has assisted the Town of Brighton in the application for a VCDP grant for the library.

On the economic development front, the Charles E. Carter Business Resource Center in NVDA's St. Johnsbury-Lyndon Industrial Park was near completion at the end of the past year. The Business Resource Center provides warehousing and manufacturing space, as well as a technical and industrial training facility. In Brighton, NVDA has assisted a small business with a grant, prepared the airport master plan, and continues to work with the Island Pond Woodworkers.

As in the past, in 2003 we continued to work closely with the Small Business Development Center to create and retain jobs throughout the Northeast Kingdom. To cite a few examples: We assisted Easton Hockey/EHM Production in Newport with a tax credit application, which will result in 60 jobs within a few years; we helped WT Solutions in St. Johnsbury to purchase industrial sewing equipment and to find a facility, thereby creating 50+ jobs; and we helped Chebe, a bread manufacturer in Orleans to locate a production facility. NVDA also continues to work with Ethan Allen on the company's long-term needs.

Companies that NVDA assisted in the recent past include MSA Gallet in Newport, which continues to grow and receive contracts for its high quality helmets from the US Army; and Bogner of America, also located in Newport, which has diversified from being solely a garment manufacturer to a warehouse and distribution center for some large clothing companies.

Four business loans were approved from our revolving loan funds in 2003. NVDA also added a technical assistance grant program in order to help small businesses with a variety of projects. We approved twelve grants for small businesses in eight communities. Projects included marketing plans, patent applications, Act 250 application assistance and an architectural design.

We look forward to continue serving you in 2004, and we appreciate your much-needed support.

I want to thank you for your past financial support, it has been greatly appreciated. As you know, last year we were able to reduce the amount of our request due to a positive performance for the previous two fiscal years. However, as we predicted last year, the reductions in reimbursement imposed by Medicare have caused us to fall back to a less optimistic bottom line. Some of this can be attributed to the \$192,436 in free services we provided last year. We are asking the voters for an appropriation to help defray some of this cost and allow us to continue to provide all of the services required in your community.

It is important to remember that OEVNA&H is unlike other non-profit organizations who work with a fixed budget—they are aware of how much money they have to spend before they provide services. Our budget is based on actual payment for services rendered and we are not compensated if there is no payment source. In fact, since we began providing services we have provided over \$825,000 worth of free care. Our budget for the upcoming year is based on projections from prior years, but if our projections fall short, so do our revenues.

We thank you for your generous support and look forward to serving your community in 2004.

Northeast Kingdom Learning Services, Inc.

We are the Northeast Kingdom Adult Education and Literacy Program (formerly Adult Basic Education). We provide on-demand home and learning center educational services to Brighton residents as well as to almost anyone in Caledonia, Essex or Orleans counties over the age of sixteen who wants to improve basic education skills. The program has full service learning centers in Newport and St. Johnsbury, part-time centers in North Troy, Island Pond, Hardwick and Lyndonville and home tutors who travel everywhere in the three counties. As always, demand for adult basic education services remains very high. In 2003, we provided over 19,000 hours of direct instruction to 948 students. We are currently serving 213 adults who are working on a GED or high school diploma. Some of our other students are studying for the Commercial Driver's License or working to improve job readiness or job skills. Our Drop-Out Recovery Program, which allows adults to earn a competency based high school diploma at no additional cost to the high school, continues to grow in popularity. We now have 7 people in the program and last year 3 earned their diplomas. We also have seen an increase in GED testing.

Your support of the Northeast Kingdom Adult Education and Literacy program will be helpful to us during the coming year. Our town monies are vital. Town funds are used for many program purposes. They have helped us pay the rent for our learning centers and offer our students higher quality and more comprehensive instructional resources. Over the years, town funds have helped us purchase workbooks, instructional supplies, reference materials and instructional software. We hope you will continue your support of the Northeast Kingdom Adult Education and Literacy program.

Vermont Association for the Blind & Visually Impaired

The Vermont Association for the Blind and Visually Impaired (VABVI) greatly appreciates the Town of Brighton for including a contribution to VABVI in their 2003 budget.

Our mission is to enable Vermonters with vision problems, whether blindness or impairment, to achieve and maintain independence. We were established with assistance from Helen Keller and the American Foundation for the Blind in 1926. Since then, our agency has provided services to any visually impaired Vermonter who needs them, at no cost to the client, due to the financial support we receive from individuals, businesses, civic organizations, and municipalities as well as state and federal grants. Last year we served 1,413 people statewide – 1,128 adults and 285 children.

Our services for children include teaching and support at home and in the classroom. Our Teachers of the Visually Impaired (TVI) instruct in Braille, and acquire materials such as textbooks in alternative formats appropriate for each child's visual impairment, whether it's Braille, large print or on audiotape. They also assist classroom teachers in instructing with less emphasis on visual learning, such as writing on the blackboard. We also plan educational overnight camps each year, so the students can exercise their independent and daily living skills in a supportive environment. In addition, we also provide transitional services for teens looking beyond high school to higher learning or independent living.

For adults, we make visits to homes to help adapt the home for safety and ease of mobility. We mark stoves, microwaves, thermostats and other appliances for ease of use and help organize pantries and closets to make cooking and other daily living tasks manageable and reasonably efficient. We provide orientation and mobility lessons, including white cane instruction, so that people can get around on their own. We sponsor Peer Assisted Learning and Support (PALS) groups, bi-monthly meetings for peer education and group support, which meet in 11 locations around the state, including Newport. We served one adult in Brighton last year.

Volunteers are an important part of our organization. Last year 204 VABVI volunteers drove 181,206 miles and donated 14,631 hours of service – the equivalent of seven and a half full time employees – either by driving, reading, shopping, brailleing, working in our offices or other capacities. It is in large part because of these volunteers that we spent 87 cents out of every dollar on direct services in your community last year. Minutes of Annual Town Meeting

MARCH 3, 2003

The legal voters for the Town of Brighton and the Brighton Water System are hereby warned and notified to meet in the Town Hall in said town on Monday, March 3, 2003 at 7:30 PM to transact the following business:

Articles 1 through 3 are to be voted by Australian ballot at the polls on Tuesday, March 4, 2003 from 9:00 AM to 7:00 PM in the town hall.

Moderator Thomas Donnellan called the meeting to order at 7:40 PM. He then read

Articles 1-3: To elect the following Town & Water System officers: Moderator, First Constable, Town Agent, Town Grand Juror, Delinquent Tax Collector and one Select person, all for one year terms; One Library Trustee for a two year term; one Select Person, One Town Clerk-Town Treasurer, one Water Commissioner, one Lister, one Auditor, one Library Trustee and one Cemetery Commissioner for the term of three years each; and one library Trustee for the term of five years.

2. To elect the following School District officers: Moderator for a one-year term; One School Director for a one-year term; two School Directors for a two-year term; and one School Director for a three-year term.

3. Shall the voters authorize the Northeast Kingdom Waste Management District to appropriate and expend a budget of \$461,476.00?

The following articles are to be considered at the business meeting portion of the Annual Town Meeting, to be conducted on Monday, March 3, 2003 at 7: 30 PM in the town hall:

4. Pledge of Allegiance to the flag was recited earlier.

5. To hear the reports of the town officers for the past year and to take action thereon. No action was taken.

6. To hear the report of the Water Commissioners for the past year and to take action thereon. No questions so no action taken.

7. To see if the voters shall fix the number of installments and the payment due dates for the collection of taxes as authorized in Title 32, V.S.A. Section 4872. Recommended payments to be due on Aug. 19, Sept. 19 and Nov. 19. Craig Goulet motioned to accept this article. Seconded by Alan Wing. Voice vote. Ayes have it. Article seven is carried.

8. To see if the voters shall authorize collection of 2003 taxes through the treasurer as provided for in Title 32, V.S.A. Sections 4792 and 4793. Edward Bickford made a motion to accept article 8. Seconded by Theodore Firestone. Voice vote called for. Ayes have it. Article 8 is passed.

9. To see if the voters shall authorize the Board of Selectmen to borrow money for the operating expenses of the Town of Brighton in anticipation of taxes-such borrowing not to exceed 90 percent of all anticipated revenues. Marshall Frizzell motioned to accept article 9. Seconded by Charles Pronto. Voice vote. Ayes have it. Article 9 is passed.

10. Will the voters authorize the expenditure of \$24,100 over 5 years to match state funds to pave Pleasant Street and to gravel Newark Road under the Class 2 resurfacing program? Edward Bickford made a motion to accept Article 10. Seconded by Marshall Frizzell. Bob Merchant explained this article. The board wants to pave one mile of Pleasant St. from the cemetery to Lakeshore Drive. This project will also include culverts and ditching. The Newark Rd. project will include three or more inches of crushed gravel on 1.7 miles on the Newark Rd. A voice vote was called for. Ayes have it. Article 10 is passed.

11. Will the voters authorize the expenditure of \$66,172.62 over three years to purchase a new town truck? Francis Allard motioned to accept article 11. Edward Bickford seconded the motion. Francis Allard made a motion to amend Article 11 to read, "Will the voters authorize the expenditure of \$66,172.62 over five years to purchase a new town truck? The annual payments of \$13,234.52 be paid from the Heavy Equipment Capital Fund." Edward Bickford seconded the motion. After much discussion a voice vote was called for. Nays have it. The amendment is defeated. Voice vote called for on original article. Ayes have it. Article 11 is passed.

12. Will the voters authorize the expenditure of \$52,000 over five years to pay for necessary repairs to the roof, flashing and eaves of the municipal building? Marshall Frizzell made a motion to accept article 12. Edward Bickford seconded the motion.

Before this article was discussed, William Johnson, our representative was present for short discussion of issues that concern our town. Act 60 seemed to be the major topic of conversation. Mr. Johnson answered a few questions, then had to leave to attend another meeting.

Peter Sprague made a motion to amend this article to read \$42,000 instead of \$52,000. Theodore Miller seconded the motion. Peter Sprague explained that the town has received a grant of \$10,000 from Historic Preservation. Voice vote on amendment. Ayes have it. The amendment is carried. Another voice vote was called for. Ayes have it. The amended article 12 is carried.

13. Will the voters authorize the appropriation of \$500 to the Frontier Animal Society of Vermont, Inc. to help defray their shelter maintenance expenses? Lindi Collins explained that the area finally has a humane society in Orleans which will cover this area. Lindi Collins motioned to accept article 13. Bernie Henault seconded the motion. Voice vote called for. Ayes have it. Article 13 is passed.

14. Will the voters authorize the appropriation of \$200 to the Essex County Natural Resources District to support their work with landowners and youth? Reginald Hunt made a motion to accept article 14. George Foy seconded the motion. Nobody seemed to know too much about this organization except that they worked with farmers and did other conservation work. Voice vote called. Too close to call so a show of hands was called for. Article 14 was passed.

15. To see if the voters will raise money by property taxes to pay the general expenses of the town and if so, how much? Charles Pronto motioned to accept article 15. Seconded by Craig Goulet. The amount of the proposed budget is \$785,411.06. A paper ballot was requested. Results: Yes-57 No-18. Article 15 is carried.

16. To transact any other non-binding business which may legally come before this meeting. Being no other business, Bernie Henault made a motion to adjourn the meeting at 9:30 PM. Joel Cope seconded the motion. All in favor. So carried.

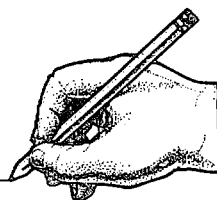

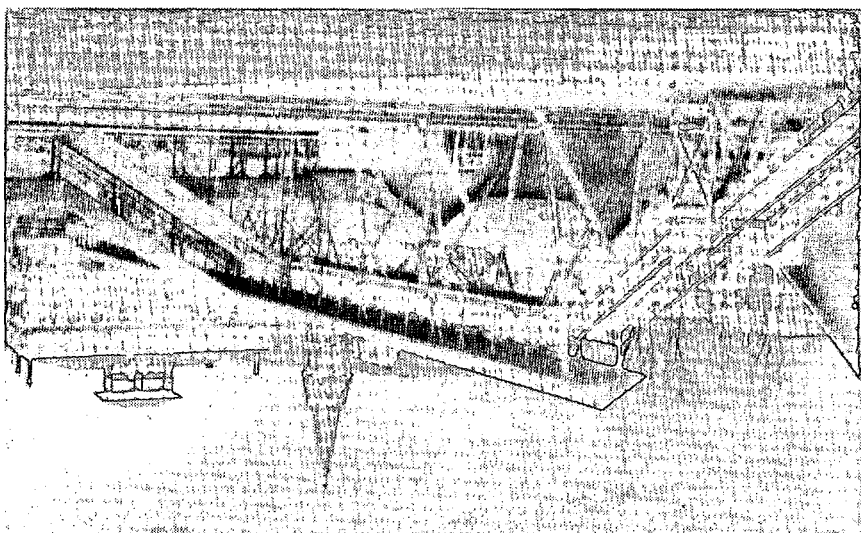

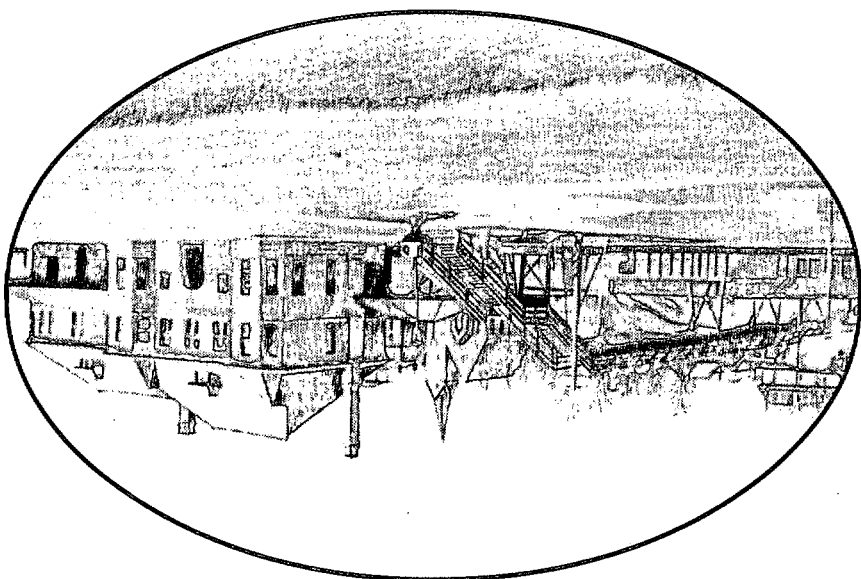

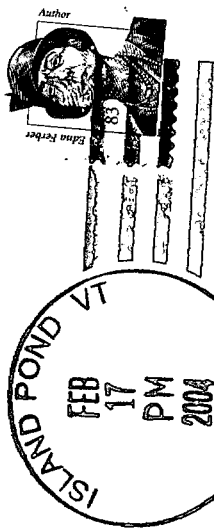
An earlier footbridge located at east end of present Railroad Station
