Attached please find records in response to your public records act request dated January 31, 2014. I have redacted contact information pursuant to 1 V.S.A. § 317(c)(7).

The Governor participated in one phone call with Safra Catz, President and Chief Financial Officer of Oracle, on November 13, 2012, from 4:00 to 4:15pm EST. There are no other responsive materials regarding your request to the Governor's Office.

As for the Agency of Administration, for your convenience, I have attached a responsive record of Secretary Spaulding. Secretary Spaulding has two other responsive records (two emails from Kate Johnson to Secretary Spaulding from November 2012) that are exempt from disclosure pursuant to 1 V.S.A. § 317(c)(15) and (c)(9) as they relate to the negotiation of a contract and appear to contain trade secret information about a potential Oracle product.

You have also sought records from Director of Health Reform Robin Lunge and Commissioner Mark Larson. To the extent you seek records from Commissioner Larson, I recommend you be in touch with the Department of Vermont Health Access, through Danielle Delong at [Danielle.Delong@state.vt.us](mailto:Danielle.Delong@state.vt.us).

I understand Robin Lunge may have responsive records. Many may be exempt from disclosure as potentially trade secret information and/or communications related to the negotiation of a contract. 1 V.S.A. § 317(c)(9) and (c)(15). To the extent you wish to further pursue her emails, I recommend you be in touch with Robin Lunge, through Marisa Melamed at [Marisa.Melamed@state.vt.us](mailto:Marisa.Melamed@state.vt.us), about the costs of production and the possibility of narrowing your request pursuant to 1 V.S.A. § 318(d).

With respect to records of the Agency of Administration, if you feel that any have been wrongfully withheld in response to this request, you may appeal to Secretary Spaulding at [Jeb.Spaulding@state.vt.us](mailto:Jeb.Spaulding@state.vt.us).
